In re: Nomination Petition for Primary Election of Thomas Miller, candidate for Attorney General

---

**OBJECTIONS TO NOMINATION PETITION:**

I, the undersigned elector who resides in the State of Iowa, object pursuant to Iowa Code § 43.24 to the Nomination Petition for Primary Election filed by Thomas Miller as a candidate for Attorney General. Miller filed his petition, along with an Affidavit of Candidacy, in the office of the Secretary of State on March 14, 2022. Miller seeks the nomination of the Democratic party.

**I. Requirements of a valid petition.**

A candidate for Attorney General needs signatures from not less than 2,500 eligible electors on his or her nominating petition. Iowa Code § 45.1(2). In addition, the candidate must have signatures of at least 77 eligible electors from at least 18 counties in the district. *Id.* The nomination petition process places demands on both the candidate and the signer to be accurate and complete.

Iowa Code § 43.14(2)(c) states that a signature line on a nomination petition “shall not be counted if an eligible elector supplies only a partial address or a post office box address, or if the signer’s address is obviously outside the boundaries of the district.” The Secretary of State’s candidate guide helpfully explains this requirement:

All signers must include the following information:

- A signature (the signature may be printed)
- **The address of their residence**

**This must include a house number, street name, and city. Providing only a post office box is not sufficient.** A signer who is homeless should describe where the signer lives or write “homeless”.

[§43.14(2), 43.15(1)]

(Secretary of State 2022 Primary Candidate Guide 8). In addition, “[a] signature line shall not be counted if any of the required information is crossed out or redacted at the time the nomination papers are filed with the state commissioner...” Iowa Code § 45.5(2)(d). Iowa Code § 43.15(3) also requires signers of petitions to include the “date of signing.” Several signature lines omit this information.

As explained above, candidates must submit nomination petitions that satisfy both a total-signature requirement and a county threshold requirement. To facilitate this, Iowa Code § 43.15(3) requires that the signers of a particular nomination petition page must be from the same county. Again, the Secretary of State’s guide to primary candidates flags this requirement:

The following information must appear on each petition candidate header for U.S. Senate, U.S. Representative, and statewide candidates:

- Signers’ County of Residence

This is required on petitions for U.S. Senate, U.S. Representative, and statewide candidates. **Each petition page should include signatures from only one county for these offices.**

[§43.15(3)]

(Secretary of State 2022 Primary Candidate Guide 7).

The code contemplates that a candidate may need to check his nomination petitions for issues such as having eligible electors from more than one county on a sheet. Iowa Code § 43.14(2)(d) states “[a] signature line shall not be counted if any of the required information is crossed out or redacted at the time the nomination papers are filed with the state commissioner...” This possibility is noted by the Secretary of State’s guidance:

**Count the signatures.**

***Best Practice:*** File more than the required number of signatures since it is possible for signatures to be challenged. **If there are signatures on a petition that should not be included, simply draw a line through the names. Those signatures will not be counted.**

(Secretary of State 2022 Primary Candidate Guide 9).

In addition to having the correct number of signatures, nominating petitions must include certain mandatory information in the header. The Secretary of State provides an official form for the use of candidates. Iowa Code § 43.8. Although a candidate may substitute his own form, it must be “in form substantially as provided” by the requirements for official nominating papers. Iowa Code § 43.10. Whatever form the candidate uses, the nominating petition “shall include or provide spaces for the following information...(e) The office sought by the candidate, including the district number, if any.” Iowa Code § 43.14(1)(e). Thus, the Secretary of State’s official nominating petition form includes blanks for this information at the top right-hand corner of the form’s header:

**Required For Federal and Statewide Petitions:** Petition pages shall contain signatures from only one county. The name of the county must appear on each petition page. This petition page contains the signatures of eligible electors from \_\_\_\_\_ county.

Iowa law makes clear the information that is required in the nominating petition and gives candidates who submit deficient papers no ability to argue that the deficiency is immaterial. “Signatures on a petition page shall be counted *only* if the information required in subsection 1 is written or printed at the top of the page.” Iowa Code § 43.14(2)(a) (emphasis added). If objections are made to a nominating petition “relating to incorrect or incomplete information for information that is required under sections 43.14 or 43.18” those objections “*shall be sustained*” (emphasis added). This sentence was added by the legislature last year. 2021 Iowa Acts, Ch. 147, § 9. In other words, the board lacks the discretion to excuse a failure to provide sufficient information. The legislature has directed in two locations that the petition header information must be complete and accurate for the signatures on that page to be counted.

One item of information that must be included in a petition header is the candidate’s county of residence. Iowa Code § 43.14(1)(c) (requiring that nomination

papers other than candidates for the general assembly include “a statement of the name of the county where the candidate resides.”) Because the candidate county residence information is mandated by Iowa Code § 43.14, the failure to include it invalidates the sheet and the board is required to sustain the objection to it.

Miller’s filing claimed to exceed 77 signatures in 21 counties:

Because in four of those counties (Black Hawk, Mills, Story, and Warren) the number of valid signatures does not equal or exceed 77, he has failed to qualify for the Democratic primary ballot.

**II. Miller submitted 77 signatures for Black Hawk County. Two of those signatures are invalid, leaving him with 75 signatures and 20 counties exceeding the 77-signature threshold.**

Miller submitted seven pages for Black Hawk County:

III. Miller submitted 77 signatures for Mills County. Twenty of those signatures are invalid, leaving him with 57 signatures and 19 counties exceeding the 77-signature threshold.

IV. Miller submitted 85 signatures for Story County. Ten of those signatures are invalid, leaving him with 75 signatures and 18 counties exceeding the 77-signature threshold.

The Iowa State University residence halls listed on page 3, line 2 and page 3, line 4 are described in the attached print out. No unit number was provided by the two signers as indicated above.

**V. Miller submitted 80 signatures for Warren County. Eight of those signatures are invalid, leaving him with 72 signatures and 17 counties exceeding the 77-signature threshold.**

Miller's Warren County nomination petitions consist of ten pages:

A print out of the Simpson College website is attached showing the address listed by these signers is for the student center, not any residence hall on campus.

**VI. Because Miller has failed to submit 77 or more signatures from at least 18 counties, he may not appear on the Democratic primary ballot for Attorney General**

Miller has failed to qualify for the Democratic primary for Attorney General because he has not complied with the requirement to submit 77 or more signatures in at least 18 counties. He is one county short of this requirement. The State Objection

Panel should sustain the objections and direct that Miller's name not appear on the primary ballot.


