This letter is in response to your April 13, 2018 email to the Department of Human Services (DHS). You indicated that you are seeking enrollment numbers for the Iowa Family Planning Network (IFPN), as well as the Iowa Family Planning Program (FPP). In addition, you are asking for data regarding services accessed by members and the unique provider count for the programs. Specifically, you requested:

**Iowa Family Planning Network enrollment numbers by months between October 1, 2016 and June 1, 2017.**

Due to the termination of the IFPN program, all members enrolled in IFPN as of July 1, 2017 were transitioned to the FPP.

**Number of services accessed by FPP members in SFY18, Q1; SFY18, Q2; SFY18, Q3:**

2,664 members accessed services or had a prescription filled in SFY18, Q1.

1,523 members accessed services or had a prescription filled in SFY18, Q2.

Data is not yet available for SFY18, Q3.

**Number of services accessed by IFPN members, if any, in SFY18, Q1; SFY18, Q2; SFY18, Q3:**

Due to the termination of the IFPN program, there were no services accessed by IFPN members beyond June 30, 2017.

**Unique provider count for the FPP in SFY18, Q1; SFY18, Q2; SFY18, Q3:**

957 providers provided a service in SFY18, Q1.

559 providers provided a service in SFY18, Q2.

Data is not yet available for SFY18, Q3.

Count of unique providers including clinicians, clinic sites including family Planning clinics, federally qualified health care centers, rural health clinics, as well as laboratories, and pharmacy services based on the providers' National Provider Identification Number (NPI).

**Unique provider count for the IFPN, if any, in SFY18, Q1; SFY18, Q2; SFY18, Q3:**

Due to the termination of the IFPN program, there were no providers participating in the IFPN program beyond June 30, 2017.
