



Governor Reynolds:

I am writing in recommendation of Jason D. Besler for appointment to State of Iowa 6th Judicial District Judge. In the approximately eighteen (18) years I have interacted with Mr. Besler in my position as a deputy sheriff — both on patrol and as a transport officer, it has always been reassuring to have one of the most rational and conscientious individuals I have ever known representing the citizens of Linn County. He is not only extremely knowledgeable of the law, but also careful to ensure that justice be served.

Justice being fulfilled does not simply mean it is completed in favor of the prosecution either. It has always impressed me how -- whether in the courtroom or in personally speaking to Mr. Besler about a case -- he has no interest in seeking conviction of anyone he truly fails to believe is guilty, and will seek to amend or dismiss charges as necessary. When his position on a matter is sought, he is very reasonable, objective, and harbors no animosity towards a defendant. I have never heard Jason request a sentence for an individual that could be considered vindictive, and he instead endeavors to deliver the most fair and ethical outcome to a case.

It would be shocking to me if there were a law enforcement or Department of Corrections officer, fellow prosecutor, Judge, or even defense attorney, who views Mr. Besler with a different perspective than what I have described above. As I reflect on my experiences with him, I cannot recall a single instance in which I have ever seen Jason get upset, much less lose his composure or appear condescending to whomever he is in contact.....either professionally or in his private life. Perhaps more important than anything, Mr. Besler is the consummate family man and absolutely adores his daughter, Chloe.

For selfish reasons, part of me would be happy for Jason to be overlooked so he will instead remain at the Linn County Attorneys Office.
