ALLEGATION: The Kim Reynolds for Iowa candidate committee has underreported the fair market value of an in-kind contribution from David North in the form of private jet service for Kim Reynolds and her husband to and from Memphis, Tennessee on or about December 30, 2017.

BACKGROUND: According to an Associated Press article, Governor Kim Reynolds and three of her family members flew to Tennessee to watch the Iowa State Cyclones play in the Liberty Bowl on December 30, 2017, on a plane owned by Sedgwick, a Memphis-based company that administers workers' compensation claims filed by injured state employees. *See* Ryan Foley, *Review: Iowa Gov. Kim Reynolds flew to Liberty Bowl on vendor's plane*, Des Moines Register (Sept. 13, 2018).¹ The Kim Reynolds for Iowa Schedule E for the 2017 reporting period discloses an in-kind contribution from David North for "Travel Flight" in the amount of \$2,880.00. *See* Ex. 1 (01/19/18 Kim Reynolds for Iowa Schedule E). Upon information and belief of the complainant based on reasonable investigation, North's company, Sedgwick, owns a 2010 Gulfstream G200. *See* Ex. 2 (flightaware.com flight registration information for N244S).

APPLICABLE LAW:

68A.402A Information disclosed on reports.

- 1. Each report filed under section 68A.402 shall disclose:
- * * *

d. The name and mailing address of each person who has made one or more in-kind contributions to the committee when the aggregate market value of the in-kind contributions in a calendar year exceeds the applicable amount specified in paragraph "b". In-kind contributions shall be designated on a separate schedule from schedules showing contributions of money and shall identify the nature of the contribution and provide its estimated fair market value. A committee receiving an in-kind contribution shall report the estimated fair market value of the in-kind contribution at the time it is provided to the committee. A person providing an in-kind contribution to a committee shall notify the committee of the estimated fair market value of the in-kind contribution at the time the in-kind contribution is provided to the committee. For purposes of this section, the estimated fair market value of the in-kind contribution shall be reported regardless of whether the person has been billed for the cost of the in-kind contribution.

351-4.17 (68A, 68B) Schedule E - In-kind Contributions.

4.17(1) Reporting of all in-kind contributions; chronological *listing.* The committee shall report the amounts of all in-kind contributions which are accepted by the committee during the reporting period. The schedule entries shall be listed in chronological order by the date on which the contribution is received.

4.17(5) Description of in-kind contribution; loaned equipment as in-kind contribution.

a. The schedule shall include a description of the good or service contributed to the committee in kind. The description shall be a clear and concise statement that specifically describes the transaction which has occurred.

b. A committee's use of equipment owned by another organization, committee, or individual is reportable as an in-kind contribution. Equipment includes, but is not limited to, typewriters, calculators, copy machines, office furniture, computers and printers.

4.17(6) *Fair market value.* The committee shall provide either the actual (if known) or estimated fair market value of the good or service received.

ANALYSIS: Multiple quotes show that the fair market value of a chartered Gulfstream G200 from Des Moines, Iowa to Memphis, Tennessee costs an average of \$35,000 for a oneday trip. *See* Ex. 3 (Jet the World Quotation 09/13/18); Ex. 4 (Air Charter Service Quotation 09/13/18); and Ex. 5 (Private Fly Quotation 09/13/18). On the low end, the fair market value of a seat on a privately chartered Gulfstream G200 would be \$2,290 per passenger. At the high end, the fair market value of seat would be \$4,229 per passenger. On average, the fair market value of a seat is \$3,108 per passenger.

The Associated Press article indicated that Governor Reynolds and her husband accepted the flight in order to campaign. Thus, the campaign contribution should be valued at the fair market value of two seats on a chartered Gulfstream G200, which would be \$4,580 on the low-end, \$8,458 on the high-end, and an average of \$6,216. Either way, it appears that Kim Reynolds for Iowa failed to disclose the fair market value of the in-kind contribution from David North.

Additionally, the Associated Press article indicates that two other relatives traveled with Governor Reynolds on Sedgwick's Gulfstream G200. If those relatives participated in the campaign event on behalf of the campaign, then the fair market value of their seats also should be reported.


