I have found no sign of any activity by lowans for a Progressive Tomorrow during 2018, other than financing three direct mailings in support of Eddie Mauro. The obvious conclusion is that donations were solicited to pay for the independent expenditures.

I still don't understand how you are in compliance with rules requiring that less than half of your organization's annual spending be related to campaigns and elections.

You are defying the Federal Election Commission's demand to disclose donors, and refusing to provide any information to me about your group's activities (if there were any after the primary), because I did not meet you for coffee last summer?

Here is an excerpt from your message of June 19:

"Happy to sit down and introduce myself to talk about the direction of lowans for a Progressive Tomorrow, and my past/future involvement with campaigns.

"Although, I will not talk about financing of lowans for a Progressive Tomorrow.

"As I indicated before, we will be following the FEC disclosure requirements. I don't believe we're required to disclose our sources of funding under FEC, or IRS law."

I didn't realize I was obligated to have coffee with you to get an answer to a simple question about your plans for the group.

It is now apparent that you have decided not to follow the FEC disclosure requirements. FEC campaign finance analyst Jamie Sikorsky wrote to you on December 4,

"Each contributor who made a donation in excess of \$200 to further the independent

expenditure(s) must be itemized on Schedule 5-A, including their identification information."

Please let me know if you have any further comments for the record.

I just realized your December 26, 2018 response to the FEC was posted in a different area of their website. I had not seen it before I sent my earlier message.


