I just wanted to briefly follow up with you regarding Senate File 63, the bill related to service animals.

In the fiscal note data request response, you state the following:

"If this bill changes the Iowa Civil Rights Act in such a way that the ICRC no longer qualifies as a FHAP, the ICRC could lose its federal funding if there was no contract with HUD. For the current fiscal year, that would be a loss of \$506,657.80. The State of Missouri recently lost their certification as a FHAP, where amendments to their civil rights law led to the loss of HUD funding for their state civil rights agencies."

Did the CRC look into whether or not this proposed bill would change the Iowa Civil Rights Act that would lead to a loss in funding? Please let me know as soon as possible!

Has the Civil Rights Commission thought about the implications to minority rights of disenfranchising felons? The League of Women Voters is working to return voting rights to persons who have been convicted of a felony. I am thinking about two particular areas.

1. Since members of minority groups are disproportionately affected by incarceration, denying voting rights hits these communities by far the hardest.

2. Requiring payment of fees, fines, and restitution to regain voting rights, again, hits these communities. In addition to higher incarceration rates, lower employment rates make restoration of voting rights harder to achieve.

Janet Abejo-Parker of the Cedar Rapids Civil Rights Commission suggested I contact you. The Legislature is making these decisions now. Would the icrc have an interest in joining the work on this issue? If you felt you

could support a particular solution, that would be good. If you felt you could add information to aid legislators as they consider this issue, that would also be good.

HF 19 – A bill for an act prohibiting employment discrimination based on unemployment status and providing remedies.

Bill Summary:

This bill prohibits employment discrimination based on an individual's status as unemployed. It seeks to amend and add sections of the Iowa Civil Rights Act (ICRA), namely 216.2 (14A), 216.2 (15), 216.6B, and 216.15 (9)(a)(10).

- New Section 216.6B adds "unemployment status discrimination" to the ICRA as an unfair or discriminatory practice. The bill defines "status as unemployed" as occurring when an individual who has applied for a job does not have a job, is available for work, and is searching for work.
- The bill outlines specific prohibitions for 1) employers and 2) employment agencies concerning the following: job postings, consideration of job applicants, hiring decisions, and altering employment agency records.
- The bill also outlines damages that an individual may recover against employers or employment agencies that are found to have discriminated on the basis of unemployment status. Damages include, but are not limited to actual damages, court costs, reasonable attorney fees, and the following when applicable under certain situations: 1) damages in an amount not to exceed \$1,000.00 for each day the unfair or discriminatory practice occurs or 2) damages in an amount not to exceed \$5,000.00 if wages, salary, employment benefits, or other compensation have not been denied or lost to the individual.

Issue Details:

- The EEOC offers some guidance on this subject on its website. See https://www.eeoc.gov/laws/practices/unemployed_status.cfm.
 - Current federal law does not prevent employers from asking about unemployed status, but the federal EEO laws do prohibit using this information to discriminate. If an employer does reject job applicants based on unemployed status, it must do so consistently, without regard to race, color, national origin, religion, sex, disability, age, and genetic information.
 - Employers also must not screen out job applicants based on unemployed status if it does not help the employer to accurately identify responsible and reliable employees and if, at the same time, it significantly disadvantages people of a particular race, color, national origin, religion, or sex.

 Other states and municipalities have passed laws prohibiting unemployment discrimination, including New Jersey, Oregon, New York City, Washington D.C., Chicago, Illinois, and Madison, Wisconsin.

Assumptions:

The ICRC assumes that passage of the proposed bill, which creates a new protected basis in the area of employment discrimination, would result in an increase of complaints filed with and investigated by the ICRC. It is likely this may necessitate the addition of employees to the staff.

Funding Sources:

The ICRC is not certain whether funding available through the EEOC contract would be available to process such complaints. The funding for such work may have to come from the General Fund or other state funds.

Estimate Fiscal/Operational Impact:

At this point ICRC is not able to estimate the fiscal or operational impact. Salary projection for one FTE (entry level) for Civil Rights Specialists for FY2020 is \$65,053.

Bill: HF 89 – A bill for an act relating to wage discrimination under the Iowa civil rights Act of 1965 and in state contracting, making penalties applicable, and establishing an equal pay task force.

Bill Summary:

This bill requires a non-state party to a contract for goods or services with the state to submit certain information pertaining to each of its employees in a report to DAS and the Iowa Civil Rights Commission (ICRC). It seeks to amend and add sections of the Iowa Civil Rights Act (ICRA), namely 216.6A (2A, 5) and 216.6A (3).

- New Section 216.6A (2A) prohibits an employer or agent of employer from engaging in the following unfair or discriminatory practices:
 - Requiring employees to refrain from disclosing, inquiring about, and discussing information about wages, benefits, and other forms of compensation.
 - o Requiring employees to sign a waiver requiring them to refrain from the activities above.
 - Discriminating or retaliating against employees who engage in the activities above.
 - Seek salary history information (incl. wages, benefits, and other forms of compensation) from job applicants and potential employees.
 - Releasing the salary history (incl. wages, benefits, and other forms of compensation) of any current or former employee to a prospective employer without written authorization from the current or former employee.
 - Publishing a job posting by any public manner without including the minimum rate of pay for the position (incl. overtime, allowances, and tips, if claimed as part of the minimum wage).
 - o Paying a new employee less than the publically advertised rate of pay for the position.
- New subsection 216.6A (5) requires the ICRC to establish a "statewide, toll-free telephone hotline" for the purpose of receiving complaints relating to wage discrimination in state contracting.
- The bill amends Section 216.6A, subsection 3, by adding an affirmative defense that a business could establish the pay differential is a bona fide factor relating to education, training, or experience.
- The bill would require creation of an "Equal Pay Task Force," to include the Director of the ICRC and twelve other directors and representatives from state agencies, labor organizations, community organizations, the general assembly, etc. The task force would study the following:

- The extent of wage disparity in both private and public sectors, between men and women, and between minorities and non-minorities.
- Factors causing wage disparities.
- o Consequences of wage disparities on the economy.
- o Prevention and elimination of wage disparities.

Issues

- At the present time, the ICRC is not staffed to operate a statewide, toll-free hotline for purposes
 of receiving complaints regarding wage discrimination.
- The affirmative defense is already available through case law in a similar form as written in this bill.
- The Equal Pay Task Force envisioned by this legislation would constitute a new area of responsibility for the ICRC Director, requiring focused time and resources on an ongoing basis and potentially requiring restructuring of current responsibilities. The bill additionally requires the ICRC to provide unspecified "staffing services" for the task force. It is unclear what additional responsibilities this would entail and at what cost to the ICRC in terms of use of existing resources and need for additional resources. The bill also requires the task force to submit a report to the Governor no later than December 18, 2020. This would certainly require focused time and resources for the ICRC Director and current employees.

Assumptions:

The ICRC assumes that passage of the proposed bill, which creates multiple new adverse actions for which individuals can file complaints alleging employment discrimination with the ICRC, would result in a significant increase of complaints filed with and investigated by the ICRC. It is impossible to anticipate at this time how much of an increase could be expected. However, it is highly likely this would necessitate the addition of employees. It is further assumed that the creation of a hotline and task force, and collection and maintenance of data, as outlined in the proposed legislation, would require significant additional funding, staff, and other resources.

Funding Sources:

There would be limited funding available through ICRC's contract with the EEOC to process complaints. The funding for the staff and procedures needed to implement all provisions of this bill would need to be provided by the General Fund and other state funds.

Estimate Fiscal/Operational Impact:

There would be a need to hire additional employees to staff a hotline and respond to the additional complaint. At least one new full-time intake officer would be needed to coordinate the process.

Salary projection for one FTE (entry level) for Civil Rights Specialists for FY2020 is \$65,053.

Unknown at this time.

Bill Summary:

This bill requires an employer to provide reasonable accommodations to an employee based on medical conditions related to the employee's pregnancy or childbirth if requested by the employee with the advice of her health care provider. It seeks to add a new subsection to the Iowa Civil Rights Act (ICRA) under the existing section on employment policies relating to pregnancy and childbirth. Iowa Code 216.6 (2)(f).

Issue Details:

Assumptions:

The ICRC assumes that passage of the proposed bill, as well as increased public awareness of the rights of pregnant employees, could result in an increase of complaints filed with and investigated by the ICRC. It is possible this would necessitate the addition of employees.

Funding Sources:

The ICRC is not certain whether funding available through the EEOC contract would be available to process such complaints. The funding for such work may have to come from the General Fund or other state funds.

Estimate Fiscal/Operational Impact:

At this point ICRC is not able to estimate the fiscal or operational impact. Salary projection for one FTE (entry level) for Civil Rights Specialists for FY2020 is \$65,053.

Unknown at this time.

Bill Summary:

This bill relates to unfair or discriminatory employment practices based on reproductive health decisions. It seeks to amend Iowa Code 216.2 (15) and add a new section 216.6B to the Iowa Civil Rights Act (ICRA).

- This bill prohibits employers from taking an adverse employment action against an employee based on the use of any drug, device, or medical service related to reproductive health by the employee, employee's spouse, or employee's dependent. It also prohibits employers from requiring employees to sign a waiver denying the right to make their own health care decisions. It also prohibits employers from retaliating against an employee for asserting their right to make their own health care decisions.
- This bill proposes an exemption for any bona fide religious institution with respect to any qualifications the institution may impose based on religion, sexual orientation, or gender identity when such qualifications are related to a bona fide religious purpose.

Issue Details:

• It is unclear whether the bill is adding a protected class to the Iowa Civil Rights Act, or whether it is to be applied to persons in already designated protected classes in 216.6 (age, race, creed, color, sex, sexual orientation, gender identity, national origin, religion, or disability). It does not specify the protected classes as are listed in other unfair or discriminatory practices in the Iowa Civil Rights Act.

Assumptions:

The ICRC assumes that passage of the proposed bill could result in an increase of complaints filed with and investigated by the ICRC. It is possible this would necessitate the addition employees.

Funding Sources:

The ICRC is not certain whether funding available through the EEOC contract would be available to process such complaints. The funding for such work may have to come from the General Fund or other state funds.

Estimate Fiscal/Operational Impact:

At this point ICRC is not able to estimate the fiscal or operational impact. Salary projection for one FTE (entry level) for Civil Rights Specialists for FY2020 is \$65,053.

Bill: HF 110 – A bill for an act relating to sexual harassment in employment policies and protections, and including effective date provisions.

Bill Summary/Issue Details:

This bill relates to sexual harassment in employment. It seeks to amend and add sections of the Iowa Civil Rights Act (ICRA), namely Sections 216.2 (15), 216.6B, 216.15 (1), and 216.15 (3)(a).

- Under Iowa Code Chapter 216, persons file complaints with the ICRC regarding sexual harassment in employment. According to the existing law, through the procedures set in place for the ICRC, complaints are screened, investigated, mediated, and litigated. Persons also have the option of requesting an administrative release (right to sue) which allows them to pursue their claims in district court. See <u>https://icrc.iowa.gov/file-complaint/outline-complaintprocess</u>.
- New section 216.6B adds "sexual harassment in employment" to the ICRA as an unfair or discriminatory practice. The ICRC is concerned that the bill, as currently written, proposes a definition of "sexual harassment" that is different from that which is currently recognized by the courts. The newly proposed definition appears to raise the standard from what is currently considered sexual harassment (meaning less claims will be successful), and may result in different standards under state and federal law.
- The bill requires the ICRC to assume many new responsibilities, including preparing and disseminating a model policy and a model poster regarding sexual harassment to employers, conducting inspection and examination of places of employment, working individually with employers to identify deficiencies in their own sexual harassment policies and providing resources and training to remedy the deficiencies, maintaining confidential records relating to inspections and investigations, developing mechanisms for reporting sexual harassment online and via a telephone hotline, developing a public education and outreach program regarding prevention and reporting of sexual harassment, and submitting to the Governor a report that includes information concerning new reporting mechanisms, number of complaints, suggestions for further legislative action, and other information. If implemented as written, this would certainly impact the work of the ICRC in myriad ways. The fiscal impact of this legislation would be very significant, likely necessitating the hiring of several additional full-time employees as well as creating a new division within the agency to focus on the area of sexual harassment in employment.

Assumptions:

The ICRC assumes that passage of the proposed bill would result in a significant increase of complaints filed with and investigated by the ICRC. It is impossible to anticipate at this time how much of an increase could be expected. The additional responsibilities outlined in the proposed legislation would require significant additional funding, staff, and other resources.

Funding Sources:

There would be limited funding available through ICRC's contract with the EEOC to process complaints. The funding for the staff and procedures needed to implement all provisions of this bill would need to be provided by the General Fund and other state funds.

Estimate Fiscal/Operational Impact:

We would need to hire several new staff members to head a compliance unit. It is not clear, but it appears the ICRC would be responsible for reviewing the harassment policies of every business in Iowa. The coordination, travel, and staff hours are almost impossible to estimate at this time.

Other questions and issues that need to be addressed:

1. ICRC would need to maintain records of all of the inspections of the businesses. Where and how would such records be maintained?

2. ICRC would need funding to create an online filing portal

4. ICRC Staff is directed to create the model policy and poster. Other human resource groups in the state may want to be involved in such a process.

5. Several new staff members would be needed to conduct the public education and outreach.

6. At least one new full-time intake officer would be needed to coordinate the online filing process.

Salary projection for one FTE (entry level) for Civil Rights Specialists for FY2020 is \$65,053.

Bill Summary/Issues:

This bill relates to service animals, service-animals-in-training, and assistance animals in housing. It seeks to amend and add sections of Iowa Code Chapter 216, the Iowa Civil Rights Act, namely Sections 216.2 (15), 216.8B, and 216.8C. It also seeks to amend sections of Iowa Code Chapter 216C, Rights of Persons with Disabilities, namely Section 216C.11.¹

 Under Iowa Code Chapter 216, persons file complaints with the ICRC regarding assistance animals in housing. According to the existing law, through the procedures set in place for the ICRC, complaints are screened, investigated, mediated, and litigated. Extensive outreach to landlords, tenants, and the general public is available and provided, through printed material and in-person trainings. For example, see the ICRC Fact Sheet on assistance animals and service dogs,

https://icrc.iowa.gov/sites/default/files/publications/2015/AssistanceAnimalsFactSheet.pdf

- New Section 216.8B defines the terms "assistance animal" and "service animal." It also makes a person who knowingly denies or interferes with the right of a person with a disability requiring a service or assistance animal to access housing, guilty of a simple misdemeanor, which is punishable by confinement of no more than 30 days, or fine of between \$65 and \$625, or both. The bill currently does not specify what entity will be responsible for enforcement, assessment of penalties, monitoring, and collection of fines. The ICRC is a neutral civil law enforcement agency. It is not sanctioned nor structured to perform regulatory or criminal functions. No federal funding could be used for such work.
- New section 216.8C places responsibility on medical professionals to make two key written findings: 1) whether a patient has a disability, and 2) whether the person has a disability-related need for a service or assistance animal. The ICRC recognizes that this provision attempts to document the findings that are needed now for a tenant to have an assistance animal, pursuant to fair housing laws; or for a person to have a service dog in a public accommodation, as outlined in the existing federal law.

¹ This fiscal note from the Iowa Civil Rights Commission (ICRC) will only address the issues raised with the Iowa Civil Rights Act, since the ICRC does not have jurisdiction under Section 216C.11. See Shumate v. Drake University, 846 NW2d 503 (Iowa 2014).

New section 216.8C (3) requires the ICRC, in consultation with the Consumer Protection Division of the Office of the Attorney General, to adopt rules regarding the making of written findings by medical professionals and specifies rules for developing a standardized form. The ICRC currently has extensive forms available on its website, which were modeled on sample forms developed by HUD. One example is Form B: Assistance Animal Requests: Health Care Professional Form,

<u>https://icrc.iowa.gov/sites/default/files/publications/2017/AssistanceAnimalsSampleHealthCareP</u> <u>rofessionalForm.pdf</u> Modifying this form in consultation with the Consumer Protection Division of the Office of the Attorney General would require focused time and effort for a short period by one of the ICRC's existing employees. The ICRC anticipates minimal fiscal impact presuming the modified form could continue to be made available online and at the ICRC office.

Assumptions:

The ICRC assumes that passage of the proposed bill, and increased awareness of the rights and responsibilities of individuals with disabilities, medical professionals, and landlords across the state, may result in an increase of complaints filed with the ICRC. However, it is not possible to anticipate at this time how much of an increase could be expected. Housing discrimination claims based on disability already are the highest number of complaints filed in the housing area. Of those complaints, for FY 2016 through FY2018, approximately 45 to 50% of the claims involved assistance animal issues.

Funding Sources:

Some of the existing funding from the U.S. Department of Housing and Urban Development (HUD) may be available to continue the existing work. However, in order for the ICRC to continue receive funding from HUD as a Fair Housing Assistance Program (FHAP), the Iowa Civil Rights Act has to be in "substantial equivalence" to the federal Fair Housing Act (Title VIII). See information at the HUD website, <u>https://www.hud.gov/program_offices/fair_housing_equal_opp/partners/FHAP</u>. If this bill changes the Iowa Civil Rights Act in such a way that the ICRC no longer qualifies as a FHAP, the ICRC could lose its federal funding if there was no contract with HUD. For the current fiscal year, that would be a loss of \$506,657.80. The State of Missouri recently lost their certification as a FHAP, where amendments to their civil rights law led to the loss of HUD funding for their state civil rights agencies.

Estimate Fiscal/Operational Impact:

As stated above, there is a concern about the loss of federal funding for housing discrimination work of the ICRC.

Bill Summary/Issue Details:

This bill relates to racial profiling by law enforcement. Racially discriminatory pretextual stops are unconstitutional, as held by the Supreme Court of the United States in *Whren v. United States*, 517 U.S. 806, 116 S.Ct. 1769 (1996). The proposed bill seeks to amend and add sections of the Iowa Civil Rights Act (ICRA), namely Sections 216.2 (15), 216.6 (1)(e), and 216.10A.

- New section 216.10A adds "Profiling" to the ICRA as an unfair or discriminatory practice.
- New section 80H.2 defines "disparate treatment" on the basis of race, color, ethnicity, religion, or national origin. This definition omits other protected bases defined in the ICRA, such as sexual orientation and gender identity.
- The bill envisions the creation of a new community policing advisory board, with the ICRC Director participating as an active voting member. This would constitute a new area of responsibility for the ICRC Director, requiring focused time and resources on an ongoing basis and potentially requiring restructuring of current responsibilities.
- New section 80H.5 may require the ICRC to create, or consult with the community policing advisory board on the creation of, a new "standard notice form" informing individuals of their right to file a complaint with the ICRC if they believe they are the victim of illegal profiling, for law enforcement to provide at stops. It is unknown what fiscal impact this could have on the ICRC at this point, as it is yet undetermined whether the police officers would hand out existing materials, such as an ICRC complaint form or brochure, or whether a new form/brochure/card referring specifically to illegal profiling would be required.
- The bill requires the ICRC to consult on data collection rules and anti-racial profiling training. The ICRC recognizes the potential benefit of collected data in its investigation and adjudication of complaints of discrimination.

Assumptions:

The ICRC assumes that passage of the proposed bill, and increased public awareness of the rights of individuals with respect to discriminatory profiling, would result in an increase of complaints filed with the ICRC. Particularly if members of the law enforcement are required to disseminate information about how to file a complaint of discrimination with the ICRC at every traffic stop ("when practicable," as

stated in the bill) and other occasions, it is highly likely this would significantly increase the ICRC's workload and necessitate the addition of full-time employees.

Funding Sources:

The funding for such work would have to come from the General Fund or other state funds.

Estimate Fiscal/Operational Impact:

At this point ICRC is not able to estimate the fiscal or operational impact. Salary projection for one FTE (entry level) for Civil Rights Specialists for FY2020 is \$65,053.

Introduction:

The Iowa Civil Rights Commission is a neutral, law enforcement agency that enforces the "Iowa Civil Rights Act of 1965." The Commission addresses discrimination in the following ways:

- Case resolution through intake, screening, mediation, investigation, conciliation, and public hearings;
- Conducting state-wide public education and training programs to prevent and respond to discrimination;
- Testing to determine the existence or extent of discrimination in Iowa.

The Iowa Civil Rights Act of 1965 prohibits discrimination in the areas of employment, housing, credit, public accommodations (public services and buildings), and education. Discrimination and harassment are illegal if based on actual or perceived race, skin color, national origin, religion, creed, sex, pregnancy, sexual orientation, gender identity, physical disability, mental disability, age (in employment and credit), familial status (in housing and credit), or marital status (in credit).

1. Executive Operating Budget Overview

ICRC received the following amounts in FY2019:

- a. \$1,198,266 in General Fund appropriation to support salaries, benefits, and general operations.
- b. \$477,284 in federal funds for reimbursement of expenses for HUD cases.

ICRC has contracted to receive the following amounts in FY2019:

- a. \$637,200 in federal funds for reimbursement of expenses for EEOC cases.
- b. \$60,850 from a grant provided by the Iowa Economic Development Authority for Building Conference (3rd Annual Build it Right).
- 2. Current Full-Time-Equivalents (FTEs)

ICRC currently has the following Employee counts:

- a. 25 Filled Positions

Letter: Greetings,

We request that the Iowa Civil Rights Commission investigate whether Iowa 4-H and Iowa State University Extension have created a hostile climate against LGBTQ individuals (including youth, volunteers and staff) and if they are fully compliant with Iowa Civil Rights Law which expressly protects LGBTQ persons from discrimination.

Over the last few months several news articles (Including the Des Moines Register, NPR, the Daily Beast, Slate and USA Today) have uncovered a pattern of exclusion against LGBTQ youth and adults in Iowa's 4-H program, which is part of Iowa State University Extension. After receiving pressure from the Trump Administration, Iowa State University Extension rolled back protections for LGBTQ youth in the Iowa 4-H program, when the Iowa 4-H Executive Director resisted they fired him.

Iowa State's public response has been to roll back LGBTQ protections because they were "controversial" and because they did not allow individuals (especially donors and elected officials) to discriminate when they felt "uncomfortable".

As reported by the Iowa State Statesman (Iowa State University student newspaper), John Lawrence, Vice President Iowa State University Extension stated -- "In my opinion, I think the policy was controversial because it got into details about pronouns and bathrooms and just because someone doesn't like it they can't do anything about it," We are most concerned about the new "accommodation" requirement (which frames beeing LGBTQ as a disability) where Iowa 4-H mandates that only an adult parent or volunteer can request an accommodation. This step in the new 4-H policy will exclude youth from using the bathroom that corresponds to their gender identity without parental consent and approval by the County Extension Office and Iowa State. In simple words they must disclose their status as LGBTQ before they ask to use the toilet.
