3	Subtitle A—Agriculture
4	SEC. 1001. FOOD SUPPLY CHAIN AND AGRICULTURE PAN-
5	DEMIC RESPONSE.
6	(a) APPROPRIATION.—In addition to amounts other-
7	wise available, there is appropriated to the Secretary of
8	Agriculture for fiscal year 2021, out of any money in the
9	Treasury not otherwise appropriated, \$4,000,000,000, to
10	remain available until expended, to carry out this section.
11	(b) Use of Funds.—The Secretary of Agriculture
12	shall use the amounts made available pursuant to sub-
13	section (a)—
14	(1) to purchase food and agricultural commod-
15	ities;
16	(2) to purchase and distribute agricultural com-
17	modities (including fresh produce, dairy, seafood,
18	eggs, and meat) to individuals in need, including
19	through delivery to nonprofit organizations and

1	through restaurants and other food related entities,
2	as determined by the Secretary, that may receive,
3	store, process, and distribute food items;
4	(3) to make grants and loans for small or
5	midsized food processors or distributors, seafood
6	processing facilities and processing vessels, farmers
7	markets, producers, or other organizations to re-
8	spond to COVID-19, including for measures to pro-
9	tect workers against COVID-19; and
10	(4) to make loans and grants and provide other
11	assistance to maintain and improve food and agricul-
12	tural supply chain resiliency.
13	(c) Animal Health.—
14	(1) COVID-19 ANIMAL SURVEILLANCE.—The
15	Secretary of Agriculture shall conduct monitoring
16	and surveillance of susceptible animals for incidence
17	of SARS-CoV-2.
18	(2) Intergovernmental cooperation.—Ac-
19	tivities conducted under paragraph (1) shall be con-
20	sistent with guidance provided by the World
21	Organisation for Animal Health.
22	(3) Funding.—Out of the amounts made avail-
23	able under subsection (a), the Secretary shall use
24	\$300,000,000 to carry out this subsection.
25	(d) Overtime Fees.—

1	(1) Small establishment; very small es-
2	TABLISHMENT DEFINITIONS.—The terms "small es-
3	tablishment" and "very small establishment" have
4	the meaning given those terms in the final rule enti-
5	tled "Pathogen Reduction; Hazard Analysis and
6	Critical Control Point (HACCP) Systems" published
7	in the Federal Register on July 25, 1996 (61 Fed.
8	Reg. 38806).
9	(2) Overtime inspection cost reduc-
10	TION.—Notwithstanding any other provision of law
11	and subject to the availability of funds under para-
12	graph (3), the Secretary of Agriculture shall reduce
13	the amount of overtime inspection costs borne by
14	federally-inspected small establishments and very
15	small establishments engaged in meat, poultry, or
16	egg products processing and subject to the require-
17	ments of the Federal Meat Inspection Act (21
18	U.S.C. 601 et seq.), the Poultry Products Inspection
19	Act (21 U.S.C. 451 et seq.), or the Egg Products
20	Inspection Act (21 U.S.C. 1031 et seq.), for inspec-
21	tion activities carried out during the period of fiscal
22	years 2021 through 2030.
23	(3) Funding.—Out of the amounts made avail-
24	able under subsection (a), the Secretary shall use
25	\$100,000,000 to carry out this subsection.

1	SEC. 1002. EMERGENCY GRANTS FOR RURAL HEALTH
2	CARE.
3	(a) Grants.—The Secretary of Agriculture (in this
4	section referred to as the "Secretary") shall use the funds
5	made available by this section to establish an emergency
6	pilot program not later than 150 days after the date of
7	enactment of this Act to provide grants to eligible appli-
8	cants (as defined in section 3570.61(a) of title 7, Code
9	of Federal Regulations) to be awarded by the Secretary
10	based on needs related to the COVID-19 pandemic.
11	(b) USES.—An eligible applicant to whom a grant is
12	awarded under this section may use the grant funds for
13	costs, including those incurred prior to the issuance of the
14	grant, as determined by the Secretary, on facilities which
15	primarily serve rural areas (as defined in section
16	343(a)(13)(C) of the Consolidated Farm and Rural Devel-
17	opment Act (7 U.S.C. 1991(a)(13)(C)), which are located
18	in a rural area, the median household income of the popu-
19	lation to be served by which is less than the greater of
20	the poverty line or the applicable percentage (determined
21	under section 3570.63(b) of title 7, Code of Federal Regu-
22	lations) of the State nonmetropolitan median household
23	income, and for which the performance of construction
24	work shall meet the condition set forth in section $9003(f)$
25	of the Farm Security and Rural Investment Act of 2002
26	(7 U.S.C. 8103(f)), to—

1	(1) increase capacity for vaccine distribution;
2	(2) provide drugs or medical supplies to in-
3	crease medical surge capacity;
4	(3) reimburse for COVID-19-related expenses
5	and lost revenue to maintain capacity, including ex-
6	penses and revenue losses incurred prior to the
7	awarding of the grant;
8	(4) increase telehealth capabilities, including
9	underlying health care information systems;
10	(5) construct temporary or permanent struc-
11	tures to provide health care services, including vac-
12	cine administration or testing;
13	(6) support staffing needs for vaccine adminis-
14	tration or testing; and
15	(7) engage in any other efforts determined to
16	be critical to address the COVID-19 pandemic, in-
17	cluding nutritional assistance to vulnerable individ-
18	uals, as approved by the Secretary.
19	(c) Funding.—In addition to amounts otherwise
20	available, there is appropriated to the Secretary for fiscal
21	year 2021, out of any money in the Treasury not otherwise
22	appropriated, \$500,000,000, to remain available until
23	September 30, 2023, to carry out this section, of which
24	not more than 3 percent may be used by the Secretary
25	for administrative purposes and not more than 2 percent

1	may be used by the Secretary for technical assistance as
2	defined in section 306(a)(26) of the Consolidated Farm
3	and Rural Development Act (7 U.S.C. 1926(a)(26)).
4	SEC. 1003. PANDEMIC PROGRAM ADMINISTRATION FUNDS.
5	In addition to amounts otherwise available, there are
6	appropriated for fiscal year 2021, out of any money in
7	the Treasury not otherwise appropriated, \$47,500,000, to
8	remain available until expended, for necessary administra-
9	tive expenses associated with carrying out this subtitle.
10	SEC. 1004. FUNDING FOR THE USDA OFFICE OF INSPECTOR
11	GENERAL FOR OVERSIGHT OF COVID—19-RE-

1	(1) APPROPRIATION.—For the purposes of ad-
2	dressing the longstanding and widespread discrimi-
3	nation against socially disadvantaged farmers and
4	ranchers in farm loan programs and across the De-
5	partment of Agriculture, as documented for decades
6	by Congress and Federal agencies, and alleviating
7	discriminatory barriers preventing socially disadvan-
8	taged farmers and ranchers from fully participating
9	in the American farm economy, in addition to
10	amounts otherwise available, there is appropriated to
11	the Secretary for fiscal year 2021, out of amounts
12	in the Treasury not otherwise appropriated, such
13	sums as may be necessary, to remain available until
14	expended, for the cost of loan modifications and pay-
15	ments under this section.
16	(2) Payments.—Using a simplified process to
17	be determined by the Secretary, the Secretary shall
18	provide a payment in an amount equal to 120 per-
19	cent of the outstanding indebtedness of each socially
20	disadvantaged farmer or rancher as of January 1
21	2021, to pay off the loan directly or to the socially
22	disadvantaged farmer or rancher (or a combination
23	of both), on each—

1	(A) direct farm loan made by the Secretary
2	to the socially disadvantaged farmer or rancher;
3	and
4	(B) farm loan guaranteed by the Secretary
5	the borrower of which is the socially disadvan-
6	taged farmer or rancher.
7	(3) Effect on eligibility.—Notwithstanding
8	any other provision of law, the provision of a pay-
9	ment under paragraph (2) to a socially disadvan-
10	taged farmer or rancher shall not affect the eligi-
11	bility of such farmer or rancher for a farm loan
12	after the date on which the payment is provided.
13	(b) DEFINITIONS.—In this section:
14	(1) FARM LOAN.—The term "farm loan"
15	means—
16	(A) a loan administered by the Farm Serv-
17	ice Agency under subtitle A, B, or C of the
18	Consolidated Farm and Rural Development Act
19	(7 U.S.C. 1922 et seq.); and
20	(B) a Commodity Credit Corporation Farm
21	Storage Facility Loan.
22	(2) Secretary.—The term "Secretary" means
23	the Secretary of Agriculture.
24	(3) Socially disadvantaged farmer or
25	BANCHER.—The term "socially disadvantaged farm-

1	er or rancher" has the meaning given the term in
2	section 2501(a) of the Food, Agriculture, Conserva-
3	tion, and Trade Act of 1990 (7 U.S.C. 2279(a)).
4	SEC. 1006. ASSISTANCE AND SUPPORT FOR SOCIALLY DIS-
5	ADVANTAGED FARMERS, RANCHERS, FOREST
6	LAND OWNERS AND OPERATORS, AND
7	GROUPS.
8	(a) Appropriation.—In addition to amounts other-
9	wise available, there is appropriated to the Secretary of
10	Agriculture for fiscal year 2021, out of any money in the
11	Treasury not otherwise appropriated, \$1,010,000,000, to
12	remain available until expended, to carry out this section.
13	(b) Assistance.—The Secretary of Agriculture shall
14	use the amounts made available pursuant to subsection
15	(a)—
16	(1) to provide outreach, mediation, financial
17	training, capacity building training, cooperative de-
18	velopment training and support, and other technical
19	assistance to socially disadvantaged groups;
20	(2) to provide grants and loans to improve land
21	access for socially disadvantaged farmers, ranchers,
22	or forest landowners, including issues related to
23	heirs' property in a manner as determined by the
24	Secretary;

1	(3) to support the development of agricultural
2	credit institutions that are designed to serve socially
3	disadvantaged groups, including other financing in-
4	stitutions funded by the Farm Credit System;
5	(4) to support the activities of one or more eq-
6	uity commissions;
7	(5) to support the development of one or more
8	legal centers focused on agricultural legal issues of
9	socially disadvantaged groups;
10	(6) to support and supplement research, edu-
11	cation, and extension, as well as scholarships and
12	programs that provide internships and pathways to
13	Federal employment, at—
14	(A) colleges or universities eligible to re-
15	ceive funds under the Act of August 30, 1890
16	(commonly known as the "Second Morrill Act")
17	(7 U.S.C. 321 et seq.), including Tuskegee Uni-
18	versity;
19	(B) 1994 Institutions (as defined in sec-
20	tion 532 of the Equity in Educational Land-
21	Grant Status Act of 1994 (7 U.S.C. 301 note;
22	Public Law 103–382));
23	(C) Alaska Native serving institutions and
24	Native Hawaiian serving institutions eligible to
25	receive grants under subsections (a) and (b), re-

1	spectively, of section 1419B of the National Ag-
2	ricultural Research, Extension, and Teaching
3	Policy Act of 1977 (7 U.S.C. 3156);
4	(D) Hispanic-serving institutions eligible to
5	receive grants under section 1455 of the Na-
6	tional Agricultural Research, Extension, and
7	Teaching Policy Act of 1977 (7 U.S.C. 3241);
8	and
9	(E) the insular area institutions of higher
10	education located in the territories of the
11	United States, as referred to in section 1489 of
12	the National Agricultural Research, Extension,
13	and Teaching Policy Act of 1977 (7 U.S.C.
14	3361);
15	(7) to provide assistance to socially disadvan-
16	taged farmers, ranchers, or forest landowners that
17	are former farm loan borrowers that suffered related
18	adverse actions or past discrimination or bias, as de-
19	termined by the Secretary; and
20	(8) to establish pilot projects to provide tech-
21	nical and financial assistance to socially disadvan-
22	taged groups, including projects that focus on land
23	acquisition, financial planning, technical assistance,
24	and credit.
25	(c) Definitions.—In this section:

1	(1) Nonindustrial private forest land.—
2	The term "nonindustrial private forest land" has the
3	meaning given the term in section 1201(a)(18) of
4	the Food Security Act of 1985 (16 U.S.C.
5	3801(a)(18)).
6	(2) Socially disadvantaged farmer,
7	RANCHER, OR FOREST LANDOWNER.—The term "so-
8	cially disadvantaged farmer, rancher, or forest land-
9	owner" means a farmer, rancher, or owner or oper-
10	ator of nonindustrial private forest land who is a
11	member of a socially disadvantaged group.
12	(3) Socially disadvantaged group.—The
13	term "socially disadvantaged group" has the mean-
14	ing given the term in section 2501(a) of the Food,
15	Agriculture, Conservation, and Trade Act of 1990 (7
16	U.S.C. 2279(a)).
17	SEC. 1007. FUNDING FOR FOOD FOR PEACE TITLE II
18	GRANTS.
19	In addition to amounts otherwise made available,
20	there are appropriated for fiscal year 2021, out of any
21	money in the Treasury not otherwise appropriated,
22	\$800,000,000, to remain available until September 30,
23	2022, for expenses, not otherwise recoverable, and unre-
24	covered prior years' costs, including interest thereon,
25	under the Food for Peace Act (Public Law 83–480), for

1	commodities supplied in connection with dispositions
2	abroad under title II of said Act.
3	Subtitle B—Nutrition
4	SEC. 1011. SUPPLEMENTAL NUTRITION ASSISTANCE PRO-
5	GRAM.
6	(a) Value of Benefits.—Section 702(a) of division
7	N of the Consolidated Appropriations Act, 2021 (Public
8	Law 116–260) is amended by striking "June 30, 2021"
9	and inserting "September 30, 2021".
10	(b) SNAP ADMINISTRATIVE EXPENSES.—In addition
11	to amounts otherwise available, there is hereby appro-
12	priated for fiscal year 2021, out of any amounts in the
13	Treasury not otherwise appropriated, \$1,150,000,000, to
14	remain available until September 30, 2023, with amounts
15	to be obligated for each of fiscal years 2021, 2022, and
16	2023, for the costs of State administrative expenses asso-
17	ciated with carrying out this section and administering the
18	supplemental nutrition assistance program established
19	under the Food and Nutrition Act of 2008 (7 U.S.C. 2011
20	et seq.), of which—
21	(1) \$15,000,000 shall be for necessary expenses
22	of the Secretary of Agriculture (in this section re-
23	ferred to as the "Secretary") for management and
24	oversight of the program; and

1	(2) \$1,135,000,000 shall be for the Secretary to
2	make grants to each State agency for each of fiscal
3	years 2021 through 2023 as follows:
4	(A) 75 percent of the amounts available
5	shall be allocated to States based on the share
6	of each State of households that participate in
7	the supplemental nutrition assistance program
8	as reported to the Department of Agriculture
9	for the most recent 12-month period for which
10	data are available, adjusted by the Secretary
11	(as of the date of the enactment of this Act) for
12	participation in disaster programs under section
13	5(h) of the Food and Nutrition Act of 2008 (7
14	U.S.C. 2014(h)); and
15	(B) 25 percent of the amounts available
16	shall be allocated to States based on the in-
17	crease in the number of households that partici-
18	pate in the supplemental nutrition assistance
19	program as reported to the Department of Ag-
20	riculture over the most recent 12-month period
21	for which data are available, adjusted by the
22	Secretary (as of the date of the enactment of
23	this Act) for participation in disaster programs
24	under section 5(h) of the Food and Nutrition
25	Act of 2008 (7 U.S.C. 2014(h)).

1	SEC. 1012. ADDITIONAL ASSISTANCE FOR SNAP ONLINE
2	PURCHASING AND TECHNOLOGY IMPROVE-
3	MENTS.
4	(a) Funding.—In addition to amounts otherwise
5	made available, there is appropriated for fiscal year 2021,
6	out of any amounts in the Treasury not otherwise appro-
7	priated, \$25,000,000 to remain available through Sep-
8	tember 30, 2026, to carry out this section.
9	(b) Use of Funds.—The Secretary of Agriculture
10	may use the amounts made available pursuant to sub-
11	section (a)—
12	(1) to make technological improvements to im-
13	prove online purchasing in the supplemental nutri-
14	tion assistance program established under the Food
15	and Nutrition Act of 2008 (7 U.S.C. 2011 et seq.);
16	(2) to modernize electronic benefit transfer
17	technology;
18	(3) to support the mobile technologies dem-
19	onstration projects and the use of mobile tech-
20	nologies authorized under section $7(h)(14)$ of the
21	Food and Nutrition Act of 2008 (7 U.S.C.
22	2016(h)(14); and
23	(4) to provide technical assistance to educate
24	retailers on the process and technical requirements
25	for the online acceptance of the supplemental nutri-
26	tion assistance program benefits, for mobile pay-

1	ments, and for electronic benefit transfer moderniza-
2	tion initiatives.
3	SEC. 1013. ADDITIONAL FUNDING FOR NUTRITION ASSIST-
4	ANCE PROGRAMS.
5	Section 704 of division N of the Consolidated Appro-
6	priations Act, 2021 (Public Law 116–260) is amended—
7	(1) by striking "In addition" and inserting the
8	following:
9	"(a) COVID-19 RESPONSE FUNDING.—In addi-
10	tion"; and
11	(2) by adding at the end the following—
12	"(b) Additional Funding.—In addition to any
13	other funds made available, there is appropriated for fiscal

22	SEC. 1014. COMMODITY SUPPLEMENTAL FOOD PROGRAM.
23	In addition to amounts otherwise made available,
24	there is appropriated for fiscal year 2021, out of any
25	money in the Treasury not otherwise appropriated,
