Hello Tami,

Under Iowa Code Chapter 22, I request the following public records:

1. Copies of records showing bonuses or retention bonuses paid during fiscal year 2020 to Iowa state agency or department directors (or the top official in the government unit, regardless of job title), with the person's name, job title, agency, base salary, and bonus amount.
2. Copies of the same records, with the same information about any state agency or department leaders who have received bonuses during fiscal year 2021.
3. Copies of records showing bonuses or retention bonuses paid to other state of Iowa employees during fiscal years 2020 or 2021, with each person's name, job title, agency, base salary, and bonus amount.
4. Records showing what funds were used to cover bonuses for state employees, if bonuses were paid from any source other than the state of Iowa's General Fund.

To reduce printing and photocopying costs, and to facilitate social distancing, I request that these records be provided in electronic format.
