Hello Gloria.

The state of lowa's pandemic payment explorer shows 12 payments to AVI Systems, Inc coming out of the Coronavirus Relief Fund on December 15 or December 16, totaling \$67,543.48. (see attached screenshots)

However, the state checkbook shows the same 12 payments on the same dates, totaling the same amount, coming from the Office of Chief Information Officer.

My understanding from documents OCIO provided as part of a previous records request is that these payments are related to work done to update the AV system in the Ray Conference Room in the governor's office suite. Please confirm.

In addition, my understanding is that these vendor payments were planned to be covered by the Coronavirus Relief Fund, and therefore coded that way on the pandemic payment explorer. (See attached image taken from spreadsheet

showing OCIO's FY21 expenditures, with the "COVD" label next to payments to AVI Systems in December.)

However, I infer that a decision was made later not to use CARES Act funds for those expenditures, which is why the state checkbook shows OCIO making those vendor payments.

Please confirm whether my understanding is accurate, and if so, when the state checkbook entries were corrected to show OCIO (not the Coronavirus Relief Fund) made those payments to AVI Systems.

Please also confirm whether the governor's office reimbursed OCIO for \$67,543.48 in payments made to AVI Systems related to any computer or audio/visual equipment installed in the Ray Conference Room.

If the governor's office did not reimburse OCIO for those payments, please tell me what funding stream OCIO used to cover the costs associated with the upgrade in the Ray Conference Room.
