Dear Secretary Pate:

I write to formally object to Anthony LaBruna's nomination petition for Iowa Senate District 3.

Under Iowa Code, a candidate for the Iowa Senate must have held Iowa residency for one year prior to the general election and also have resided in the district they seek to represent for at least 60 days. This would mean that all candidates would need to have established permanent Iowa residency by November 8, 2021 in order to qualify for the November 8, 2022 ballot.

According to public documents and statements from LaBruna himself, he has resided in Washington, D.C., Florida, and Iowa all within the last several months. His sudden "move" to Senate District 3 has raised many eyebrows and warrants further investigation into exactly when he legally established residency in the State of Iowa.

- In a text message to a colleague from Iowa on August 22, 2021 LaBruna expressed that
 he was in Iowa for the state fair but "heading home in a couple of days." When asked if
 LaBruna was still residing in D.C. or back in California he replied "Florida."
- On September 3rd of 2021, LaBruna appeared on WHO Radio for an interview where he
 discussed that he was back in Iowa visiting friends but residing in the State of Florida.
 When asked if he would be back in Iowa for a visit by former President Donald Trump,
 LaBruna replied that he hoped so.
- A media release on November 23, 2021 from the campaign of U.S. Senator Chuck Grassley identified LaBruna as a resident of Des Moines, IA.
- A media release from LaBruna dated December 1, 2021 announcing his candidacy in lowa Senate District 3 also listed the location of the announcement as Des Moines, IA (although Des Moines is not in Senate District 3.)
- When asked to provide his address to the Storm Lake Times during an initial candidate interview, LaBruna declined to disclose where he lived.
- In LaBruna's Affidavit of Candidacy on file at the Iowa Secretary of State's office, he lists two addresses. His home address 427 East 3rd Street in Sanborn, Iowa (O'Brien County) and a mailing address of P.O. Box 931, 509 Cayuga Street, Storm Lake, Iowa (Buena Vista County). 509 Cayuga Street is the physical address of the U. S. Post Office in Storm Lake.

Given the fact that LaBruna is not a native Iowan and has very publicly lived and worked outside of state so recently, I ask that your office verify the following:

- When and where did LaBruna establish legal residency in the State of Iowa?
- When and where did LaBruna establish residency in Iowa Senate District 3?

Until these questions are answered, the public cannot in good faith believe that LaBruna has met the legal requirements to be elected to the lowa State Senate as established in lowa Code.



Anthony LaBruna Announces Candidacy for Iowa State Senate

December 1°, Des Moines, Iowa - Anthony LaBruna announced today he is running to represent Iowa's 3rd District Senate seat. LaBruna most recently served as President Trump's White House Liaison to the United States Department of Commerce. Youthful transplant to Storm Lake runs for Iowa Senate

LaBruna, who worked for Trump, takes on Aurelia native Lynn Evans December 22, 2021

The race for the opening Iowa Senate seat that covers Buena Vista and four counties to its northwest is shaping between a longtime school superintendent and a 24-year-old former cabinet official for President Donald Trump.

Experience is expected to be a major sticking point.

Lynn Evans, 57, of Aurelia, was the superintendent of two school districts in Senate District 3 and graduated from Aurelia High School in 1982. He touts a 35-year career as a teacher and education administrator.

Anthony LaBruna, who recently moved to Storm Lake "around the BVU area," cited his role as President Donald Trump's liaison to the commerce department.



Anthony LaBruna moved to Storm Lake and is running for the Iowa Senate.

At age 22, he managed 213 employees and a \$30 million budget. He also worked for the Trump's campaign in Iowa and as a page for State Rep. Jarad Klein, R-Keota.

"Taken by surprise, you could say," Evans said of his opponent in the Senate race. "He's an ambitious kid. I give him credit for that. We'll see what the voters want, my record or his. I'm proud to share mine."

LaBruna told The Storm Lake Times he plans to tout his brief stint in the Trump cabinet and hot-button issues among Northwest Iowa conservatives: inflation, education reform and administrative oversight.

He was quick to note his stint in the Trump cabinet gave him "a perspective about what's wrong with bureaucracy." He plans to bring a deficit-hawk view to the Legislature.

"I worked in the federal government. The stories you hear about hammers costing (thousands of dollars) are everywhere," he said in a phone interview earlier this month. "People need someone with that view in the Legislature. I want to protect our tax dollars from common abuses."

The driving question among election observers is whether Evans' relationships during his superintendent tenures can overcome his questionable policy credentials among the conservative wing of Iowa Republicans. He lost a House primary in 2020 to Dennis Bush of Cleghorn by less than 300 votes.

The most ardent voters show up for primaries; whether they are motivated to vote for Evans this time around is an open question.



Filing Deadline Expires For State And Federal Offices



3/18/2022

(Des Moines)— The filing deadline for state and federal offices closed at 5:00 pm Friday (March 18th). There's no incumbent in Iowa Senate District 3, but there are two Republican candidates. That sets the stage for a June primary election between Lynn Evans of Aurelia, and Anthony LaBruna of Storm Lake. There is no Democrat on the ballot. Senate District 3 includes parts of Buena Vista, Cherokee, Clay, O'Brien and Osceola Counties.

In Iowa Senate District 5, which covers parts of Clay, Dickinson, Emmet and Palo Alto Counties, incumbent Republican Dave Rowley of Spirit Lake will face Republican David Dow of Emmetsburg in a June primary. There is no Democrat on the ballot.

There are multiple contested races for seats, in the lowa House, representing northwest lowa. In House District 4, which covers all of Lyon County, and the northern half of Sioux County, two Republicans will meet in the June primary. Incumbent Skyler Wheeler, who lives in House District 3 right now, will move his family into District 4 before the general election. He'll face Republican Kendal Zylstra, of Larchwood, in the primary. There is no Democrat on the ballot.

There will be a three-way Republican primary in House District 5. Republican incumbent Dennis Bush of Cherokee is challenged by Zachary Dieken of Granville, and Thomas Kuiper of Sibley. They'll meet in the June primary. There is no Democrat on the ballot.

In House District 6, Republican incumbent Megan Jones of Sioux Rapids will face Democrat James Eliason of Storm Lake in the November general election. House District 6 includes much of Buena Vista County and the southern half of Clay County.
