Order Reprimanding and Issuing Civil Penalty

THIS MATTER comes before the Iowa Ethics and Campaign Disclosure Board this 3rd day of November, 2022, to consider a reprimand and the issuance of a civil penalty.

For the following reasons, the Board hereby reprimands Eddie Andrews, in the capacity as Candidate for Eddie Andrews for Iowa, and orders him to pay a civil penalty in the amount of \$500.

On June 3, 2022, Karin Derry filed FC 2022-14 alleging that Eddie Andrews violated Iowa Code chapter 68A beginning in June 2022. Complainant alleges that Respondent failed to include attribution statements on large campaign signs (colloquially known as barn signs) as required by Iowa Code section 68A.405.2 Complainant provided photographic evidence showing barn signs with no visible attribution statement.

In response to the Complainant's allegations and evidence, Board staff first contacted Respondent for photographic evidence of compliance with the law on June 20, 2022.<sup>3</sup> Following an additional attempt by Board staff to contact Respondent in late June 2022, Respondent indicated that photographic evidence would be provided. No such evidence of compliance was received before the September 22, 2022, Board meeting. On September 22, 2022, the Board voted to accept the complaint and authorized an investigation into the allegations. Also on September 22, 2022, Respondent provided photographic evidence proving that his campaign signs were in violation of the law by including an inaccurate attribution statement.<sup>4</sup>

Board staff contacted Respondent on October 28, 2022, asking for an update regarding the status of attribution statements on the barn signs at issue and for probative photographic evidence.<sup>5</sup> No response was received from Respondent. Board staff again contacted Respondent on October 31, 2022, asking for the same.<sup>6</sup> Again, no response was received from Respondent.

On October 31, 2022, Board staff communicated with a member of the public regarding an unrelated matter. During the conversation, the member of the public identified themselves as a volunteer with Respondent's campaign and offered to assist in providing photographic evidence for this matter. On November 1, 2022, the volunteer provided Board staff with photographic evidence showing that proper attribution statements had been added to the barn signs at issue.<sup>7</sup> The volunteer confirmed that all barn signs now have the requisite attribution statement.<sup>8</sup>

From the first time Board staff contacted Respondent on June 20, 2022, until the volunteer provided photographic evidence on November 1, 2022, the burden of proof was on the Respondent to prove to the Board that he was in compliance with Iowa law concerning his barn signs. Yet, for nearly five months, Respondent ignored the Board's requests for proof that his campaign had followed the law. In this matter, the public has been deprived of information from Respondent that Iowa law requires.

For the aforementioned reasons, we find probable cause to believe the Eddie Andrews for Iowa committee violated Iowa Code section 68A.405 and Iowa Administrative Code rule 4.38 by failing to include the required attribution statement on certain campaign signs.

Pursuant to Iowa Administrative Code rule 351-9.4(2), the Board elects to handle this matter by administrative resolution rather than through a contested case proceeding.

IT IS SO ORDERED: In his capacity as Candidate for the Eddie Andrews for Iowa committee, Eddie Andrews is hereby reprimanded and ordered to pay a civil penalty of \$500. Upon payment of the penalty, FC 2022-14 is dismissed as administratively resolved pursuant to Iowa Administrative Code rule 9.4(2).




It's possible that an email went to spam but to my knowledge I was not informed by the board of today's meeting and found out at the last minute. The attributions have already been placed o


