

COMES NOW the above-named Defendant in the above-captioned criminal case, via the undersigned and states:


1. I am represented by Attorney Nicholas Dial, whose address and telephone number is: Des Moines Adult Public Defender’s Office, 505 5th Avenue, Ste 506, Des Moines, IA, 50309-2320; (515) 725-1825.
2. My current residence and mailing address is: 2021 38TH Street, Des Moines, IA 50310.
3. I am 48 years old, having been born on August 1, 1975. I can read and understand the English language.
4. I have been advised by the above-named attorney and understand that I have a right to arraignment in open court, and I hereby voluntarily waive that right, choosing instead to have my attorney file this written arraignment and plea of not guilty on my behalf. I understand that times for further proceedings which are computed from the date of arraignment will be computed from the date of filing this written arraignment and plea of not guilty.
5. I have received a copy of the Trial Information. I have read the Trial Information, and I have familiarized myself with its contents. The State has charged me with the crimes of:
 - i. Count 1 – Possession with Intent to Deliver (Marijuana), in violation of Iowa Code section 124.401(1)(d), a class “D” felony;
 - ii. Count 2 – Possession with Intent to Deliver (THC Gummies), in violation of Iowa Code section 124.401(1)(d), a class “D” felony;
 - iii. Count 3 – Failure to Possess a Tax Stamp, in violation of Iowa Code section 453B.12, a class “D” felony; and

- iv. Count 4 – Possession of a Controlled Substance (Marijuana), in violation of Iowa Code section 124.401(5), a serious misdemeanor.
6. With regard to the name by which I am charged in the Trial Information: The name shown on the Trial Information is my true name. I have been advised and understand that I am now precluded from objection to the Trial Information upon the ground I am improperly named.
7. I have been advised and understand that I may plead guilty or not guilty.
8. For the purpose of this arraignment, I have had sufficient time to discuss my case with the above-named attorney and I waive any further time in which to enter a plea.
9. I plead NOT GUILTY to all charges.
10. I have been advised and understand that I have a right under Rule 2.33(2)(b) of the Iowa Rules of Criminal Procedure to a trial within 90 days after indictment/filing of the Trial Information and (check either “a” or “b”):
- (XX) a. I demand a speedy trial pursuant to Rule 2.33(2)(b).
- () b. I waive my right to a speedy trial pursuant to Rule 2.33(2)(b).
11. I have discussed this written arraignment with my attorney. I understand fully what this document entails.
