Gov. Reynolds Announces Staff Changes

DES MOINES – Gov. Reynolds today announced that Dax Oberreuter will join her administration as policy advisor for health care and veteran's affairs. Oberreuter most recently served as legislative liaison at the lowa Department of Health and Human Services (HHS). He previously held the same position for the lowa Department on Aging and served as the agency's public information officer and planning and innovation administrator. He holds a Master of Business Administration degree from the University of Iowa. The position was previously held by Clare Kelly who is leaving the Office of the Governor to become the chief advocacy officer for the Iowa Hospital Association.
