

The attached document was timely prepared by the applicable filing deadline.

As a result of the federal government shutdown that began on October 1, 2025, the FCC’s online public inspection file (OPIF) system was inaccessible and non-functioning from October 1, 2025, until November 18, 2025. *See, e.g., Impact of Potential Lapse in Funding on Commission Operations*, Public Notice, DA 25-922 (rel. Sept. 30, 2025). Consequently, the Licensee was unable to upload the attached document until after the “normal” filing deadline. *Id.* at 2 (“In the event operations are suspended, the normal filing deadlines under the Commission’s rules are extended by this *Public Notice* . . .”).

Following legislative action on November 12, 2025, to reopen the federal government, OPIF deadlines during this period were initially extended “until at least” November 18, 2025. *See Additional Guidance Ahead of Resumption of Operations and Extension of Filing Deadlines*, Public Notice, DA 25-937 (rel. Nov. 13, 2025). The deadlines to upload OPIF documents were then further extended, as follows:

- December 1, 2025, for Third Quarter 2025 Issues/Programs Reports.
- November 24, 2025, for EEO Public File Reports that were due on October 1, 2025.
- November 24, 2025, for responses to the Enforcement Bureau’s EEO audit letter that were due on October 17, 2025 (see *Enforcement Bureau Announces 2025 EEO Audits*, Public Notice, DA 25-673 (rel. Aug. 8, 2025)).
- Political file records of requests for time received from October 1, 2025, through November 12, 2025, on the schedule below:
