Comes now, the undersigned counsel, on behalf of Plaintiff and hereby respectfully requests that the Court enter an Order requiring the above-named Defendants to appear before this court located at 210 Central Ave S., Orange City, Iowa and answer questions under oath regarding Defendants' property and income. In further support of said Motion, the undersigned states as follows:

1. A Petition for Money Judgment was filed in this matter on February 25, 2026.
2. After proper service and notice, a Default Judgment was entered April 16, 2026, against the Defendant in favor of the Plaintiff in the amount of \$182,244.70 plus court costs, expenses, and interest.
3. A Praecipe was filed with the Court on May 12, 2026.
4. A General Execution was issued by the Clerk of Court on May 12, 2026.
5. The General Execution as well as Dictation for Execution was served upon WCF Financial Bank.
6. WCF Financial Bank answered and indicated that Wulf had no funds. No funds were received as a result of the garnishment.
7. The entire Judgement issued on April 16, 2026, remains unsatisfied.
8. Defendant has made no effort or attempt to pay the debt owed to Plaintiff.

9. Plaintiff has made diligent efforts to locate assets of the Defendant, including income and other bank accounts, to no avail. Plaintiff has not been able to ascertain the whereabouts of any assets of the Defendant.
10. Plaintiff is requesting that the Court issue an Order pursuant to Iowa Code 630.3 which requires Defendant to appear before this Court and be subject to a Debtors exam.
11. Plaintiff further requests that Defendant be ordered to bring the following documents with them to the Debtor's Examination: last twelve months of paycheck stubs, last twelve months of bank statements, last twelve months of mortgage statements, vehicle titles, tax returns for previous five years, profit and loss statements for any business interests for the past twelve months.
