I was very pleased to learn that the judicial nominating committee selected Mike Jacobsen as one of the two nominees to fill the judicial vacancy in judicial sub-district 5A. Although I practice in judicial sub-district 5B, our court service days, hearings and trials are often covered by 5A judges, so it is very important to me that we have the highest caliber attorneys serving as judges in that sub-district. Over the years we have been fortunate that many excellent attorneys have been appointed to serve as judges in 5A, and Mike's appointment to the bench will maintain these high standards.

#### Dear Ryan:

The chief justice asked me to write to you regarding the appointment process for the most recent district judge position in the 6<sup>th</sup> judicial district. I hope I do not sound too formal, but I think it is important to speak in a way that captures the true thoughts and feelings of the chief justice about the essential need for trust in government and its application to this matter.

Those authorized to act in government must often also decide what is required to be done to carry out their responsibilities. This is true in making a judicial appointment under the Constitution. It means it is up to the governor to give meaning to the constitutional directive for judicial appointments to be made within thirty days. This decision is not unlike many decisions that must be made throughout government each day to carry out the responsibilities within each branch of government. Indeed, it is a critical part of our democratic process and the reason public officials take an oath to support the Constitution and the law. The chief justice understands and appreciates the responsibility of the Governor and other public officials to make such decisions, and views that authority and discretion with the greatest deference and respect. He believes respect and comity from within government is as essential to achieving greater public trust and confidence of government, as are the checks and balances built into government.

In practice, the chief justice has always considered a judicial appointment was made when it was communicated to the nominee. This communication from the governor to the nominee is a time-honored practice that every judge in this state has experienced, and an honor no judge has ever forgotten. To my knowledge, it is a practice that has always occurred within

thirty days of the nomination by the judicial nominating commission. Nevertheless, this long-standing practice does not mean judicial appointments cannot be made in other ways.

With the recent district judge appointment in the 6<sup>th</sup> judicial district, the Governor's Office communicated to the chief justice, the secretary of state, and the public that the appointment of Jason Besler as district court judge was made on Thursday, June 21, 2018, which was day thirty following the nomination. You have further communicated that Governor Reynolds made "the verbal appointment" on that date, but did not notify Besler or issue a public statement on the appointment until Monday, June 25, 2018. Although the appointment was not communicated to Besler or made public until Monday, June 25, Governor Reynolds determined that the appointment was made on June 21 when she made the decision to select Besler. Consequently, the chief justice respectfully defers to and accepts the decision by Governor Reynolds that this appointment was made on June 21.

#### Judicial Appointments

The Iowa Constitution grants the Governor the authority to appoint district court and appellate judges from the list of nominees submitted by the district or state judicial nominating commission. See Iowa Const. art. V, § 15. But "[i]f the governor fails for thirty days to make the appointment, it shall be made from such nominees by the chief justice of the supreme court." Id.; see also Iowa Code § 46.15 (requiring the Chief Justice to make the appointment if the Governor does not "make an appointment within thirty days after a list of nominees has been submitted").


The Governor makes an appointment when she chooses the nominee to serve as a judge. See Johnson v. Sampson, 24 S.W.2d 306, 308 (Ky. 1930) ("It seems to be quite universally conceded that the 'mere making of an appointment' consists only 'in the choice by the appointing power of the person appointed,' and when that condition of mind is reached with the appointer he has in his own mind made an appointment."); Johnston v. Wilson, 2 N.H. 202, 203 (1820) (stating the "general principles" that "the choice of a person to fill an office constitutes the essence of his appointment" and that "[a] fter the choice, if there be a commission" or other formalities, "these are forms only which may or may not be necessary to the validity of any acts under the appointment, according as usage and positive statute may or may not render them indispensable").

As long as the Governor chooses from the nominees within the required thirty days, she has made the appointment. And the Chief Justice is thus not required to make it. See Iowa Const. art. V, § 15. This is so even if the Governor does not inform the appointed judge or publicly announce the appointment until a later date because neither of these actions are necessary for the Governor to make the choice. Cf. Chief Justice John G. Roberts, 2016 Year-End Report on the Federal Judiciary, available at https://www.supremecourt.gov/publicinfo/year-end/2016year-endreport.pdf (recounting that one of the first U.S. district court judges was appointed and confirmed without his knowledge until President Washington wrote to inform him of his unexpected new judicial office).

To be sure, the appointment is an official act of the Governor that must be recorded in the executive journal. See Iowa Code § 7.2 ("The governor shall cause a journal to be kept in the executive office, in which a record shall be made of each official act as done, except if in cases of emergency an act is done away from the office, such entry shall be made as soon thereafter as may be."). And the appointment "shall be in writing" and filed in the Secretary of State's Office. Id. § 69.10; see also id. § 62.23(1). But failure to comply immediately with these documentary requirements would not affect the validity of an appointment and would instead merely "be an irregularity only which could be complied with at any time." State ex rel. Halbach v. Claussen, 250 N.W. 195, 201 (Iowa 1933). This makes particular sense given the purpose of this Constitutional provision, which is designed to prevent a governor from shrinking the judiciary by refusing to fill judicial vacancies. See Todd E. Pettys, The Iowa State Constitution 232 (2d ed. 2018).

A contrary interpretation of these statutory provisions would infringe upon the Governor's constitutional authority to appoint judges. The Constitution merely requires that the Governor "make the appointment" and provides thirty days for the Governor to consider this important decision. See Iowa Const. art. V, § 15. Requiring that other acts—such as the writing and filing of the appointment—also to occur within the thirty-day period granted by the Constitution would necessarily reduce the time available the Governor to make the appointment. And conditioning the Governor's constitutional authority to make the appointment on the satisfaction of these additional statutory requirements would impermissibly alter the balance of the appointment power between the Governor and the Chief Justice. This, a statute cannot do.

The people of Iowa could have imposed additional duties on the Governor with respect to appointments in the Constitution, but they did not do so. In fact, the Iowa Constitution—unlike the U.S. Constitution—does not require the Governor to issue a commission to judges or other state officers. *Compare* U.S. Const. art. II, § 3 (requiring that the President "shall Commission all the Officers of the United States"), with Iowa Const. art. IV, § 21 (providing certain requirements for "grants and commissions" but not authorizing or mandating their issuance); *see also* Iowa Code § 9.3; Iowa Attorney General Opinion to G.W. Kirtley, 1937 WL 67730 (Apr. 3, 1937) ("There is no provision in the constitution or in the statutes which definitively sets out the scope of authority of the governor to issue commissions to appointed officers.").
