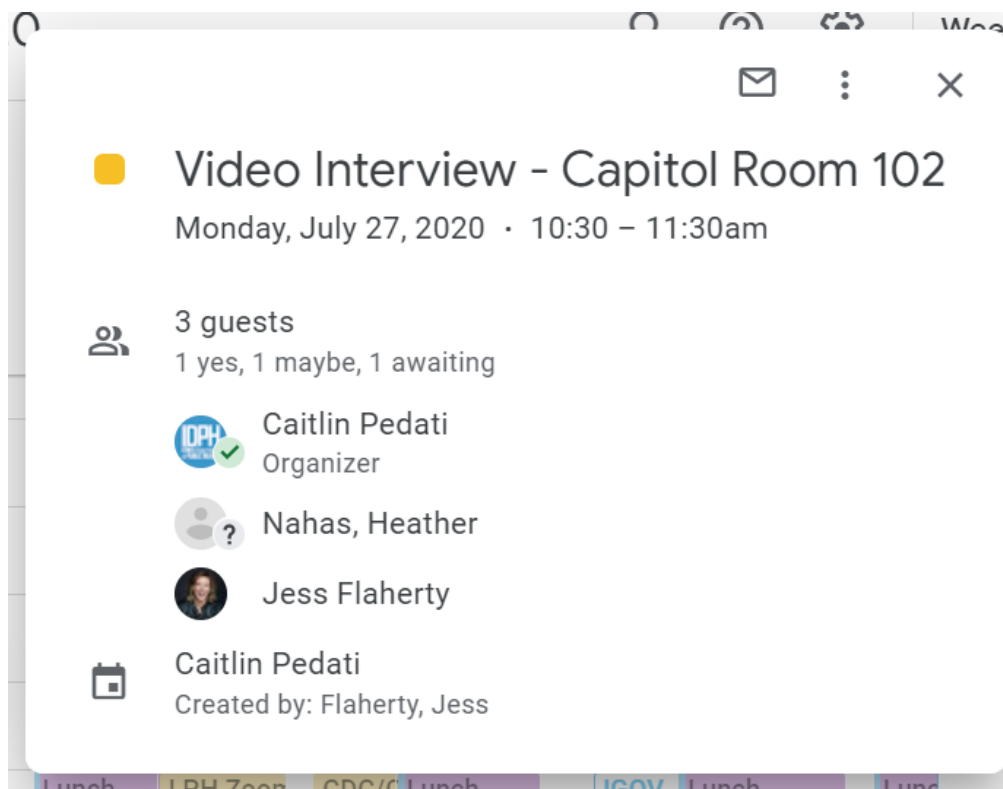

3. Copies of written correspondence in the possession of IDPH related to DOMO's plans to film inside the state Capitol building. I am seeking copies of any such records, whether IDPH personnel were the senders, recipients, or cc'd on the communication. That is, regardless of whether such communication originated with a DOMO representative, Director Paul Trombino or anyone else at the Department of Administrative Services, anyone working in the Office of the Governor, anyone working for the Iowa legislature, Dr. Pedati, Dr. Pedati's administrative assistant,

or anyone working at the Iowa Department of Public Health. IDPH does not have any records responsive to this request.

I am requesting all such emails in possession of IDPH, whether they were sent or received through accounts normally used by staff or the "ECC" addresses used for some communication related to the COVID-19 pandemic or private email accounts. The Iowa Public Information Board has confirmed that emails from private accounts are subject to the open records law if such accounts are used to discuss government business.

Written correspondence includes but is not limited to emails, mailed or hand-delivered letters, internal memos, text messages via cell phone or Apple Watch or iMessage service, and direct messages sent through apps or social media platforms.

4. Copies of any instructions that Governor Reynolds or any staff working in the Office of the Governor or the Department of Administrative Services provided to Dr. Pedati regarding protocols or restrictions related to filming the DOMO video. IDPH does not have any records responsive to this request.

To reduce printing and photocopying costs and to facilitate social distancing, I request that these records be provided in digital format and sent to me via email.
