I was specifically asking about strike teams that had lowa National Guard involvement, such as the testing at GMT on May 22. How many of those were there, and when did they occur? I am trying to get a sense of how long the "strike team" program existed and how many workplaces and long-term care facilities benefited from that approach to COVID-19 testing.

You had previously written on January 12, "I am attaching a redacted version of the strike team calendar. Names of businesses are redacted pursuant to Iowa Code section 139A.3(2)(c)." Now you are saying that list included businesses that did COVID-19 testing with "no state staff or assets deployed," so you have no documentation of the dates for six of the businesses visited.

How can IDPH not be aware of when businesses conducted their own mass COVID-19 testing?

Why were those testing events included on the document you sent me on January 12, if they didn't involve strike teams? And are you telling me the IDPH has no record of when these strike team testing events occurred? Or are you claiming you can withhold the dates because county public health or private companies administered the COVID-19 tests? If so, on what grounds are you withholding the dates? I see nothing in Iowa Code Chapter 22 that allows IDPH to withhold the dates on which employees in congregate workplaces were tested for COVID-19. Hello Sarah,

I'm seeking further information about manufacturing workplaces that received visits from "strike teams" involving the Iowa National Guard and/or IDPH staff.

How many lowa food processing facilities received a strike team visit while this program was active? Please send the name of the company and the city and date of each visit.

How many lowa manufacturers not connected to the food system received a strike team visit while this program was active? Again, please send the name of the company and the city and date of each visit.

For instance, I know a strike team visited GMT in Waverly on May 22. I know that in late April, the governor's office was in discussions with TMI Composites in Newton about a testing plan.

However, I don't know whether TMI got a strike team visit (and if so, when), or whether IDPH simply sent a few hundred COVID-19 testing kids to TMI for surveillance testing to be conducted by others.
