3. A copy of the FY 2022 budget vs actual Fiscal Year End Report for the governor's office (including the State-Federal Relations office).

4. Copies of any written records signed (either electronically or by hand) by Governor Reynolds or by Sara Craig/Sara Craig Gongol, relating to the use of federal funds (including but not limited to funds received through the CARES Act/Iowa Coronavirus Relief Fund, or the American Rescue Plan) to cover salary or benefits for staff in the governor's office during any part of fiscal year 2022.

If the documents requested in numbers 2, 3, and 4 are not immediately available, please send me the documents requested under number 1 first and the rest of the records when they are available.

To reduce printing and photocopying costs, and to facilitate social distancing, I request that these records be provided in electronic format via email.
